Glenn McGrath AM

Former Australian Cricketer & McGrath Foundation President

Regarded as one of the greatest cricketers of all time, Glenn McGrath AM has amassed an impressive array of achievements throughout his illustrious cricket career and through his role as Chairman of the McGrath Foundation. Glenn has won many awards, including the impressive Allan Border Medal 2000, Test player of the Year 2000, One Day International Player of the Year 2001, Wisden Cricketer of the year 1998, Wisden Cricketer of the Year during the season 1999 and 2005-6. His outstanding accomplishments also include the seventh-highest tenth wicket partnerships and two tenth wicket partnerships. In 2008 Glenn was honoured a member of the Order of Australia for 'service to cricket as a player'. Later that same year, Glenn was the recipient of the NSW Australian of the Year Award acknowledging his leadership and tireless dedication to the McGrath Foundation.





Bill Evans *Economist and Head of Research, Westpac*
